

STANDARD AGREEMENT
ADDENDUM TO AGREEMENT BETWEEN LOCAL PRESENTER AND PERFORMING ARTS SOCIETY OF
ACADIANA (PASA)

1.ENGAGEMENT: Local Presenter engages PASA to provide Artist, who agrees to perform at the Date, Time and Place of specified for the COMPENSATION specified in the AGREEMENT BETWEEN LOCAL PRESENTER AND PERFORMING ARTS SOCIETY OF ACADIANA.

2. HALL: Local Presenter represents that he has a lease covering the performance(s) and the rehearsal, which will be shown to PASA upon request. Local Presenter agrees, at his own expense, to furnish the aforementioned Hall on the date(s) and at the time for the performance(s) and the rehearsal herein contracted for, well heated, lighted, clean and in good order, with all necessary attaches and special police, ushers, ticket sellers, ticket takers , licenses (if required), clean dressing room for Artist near the stage, and clean and adequate dressing rooms for accompanist and assisting artist(s), if any, as well as ticket sellers for advance and box off ice sales, both at the box office and at any place other than the Hall at which advance sales may be made.

3.PROGRAM: PASA will furnish or cause to be furnished to Local Presenter a copy of the program to be performed, and Local Presenter agrees, at Local Presenter's expense, to print and distribute a sufficient quantity of house programs in conformity with the material furnished by the Artist. Local Presenter is responsible for payment of all licensing fees.

4. PUBLICITY: PASA agrees to furnish publicity material for use by the Local Presenter.

5.ADVERTISING: All advertisements made or placed by Local Presenter shall carry logo and name of the Performing Arts Society of Acadiana.

6. IMPOSSIBILITY OF PERFORMANCE: PASA and the Artist shall be under no liability for the Artist's failure to appear or perform in the event that such failure is caused by or due to the physical disability or illness of Artist, or acts or regulations of public authorities, labor difficulties, civil tumult, strike, epidemic, interruption or delay of transportation service, or any other similar or dissimilar cause beyond the control of the Artist.

7. RESTRICTIONS: Local Presenter agrees to prevent the broadcasting, recording, or reproduction by radio, television or any other device of the Artist's Performance, or any part thereof. Local Presenter agrees that, except to the extent otherwise specified in this Agreement, the Performance by the Artist shall not be in conjunction with any other performance and that no assisting artist shall perform without the prior written consent of PASA.

8. CANCELLATION: In case of a cancellation by Local Presenter which results in the need to postpone the concert, the concert is to be rescheduled for a later mutually convenient time. If Artist is en route during cancellation, travel expenses must be borne by Local Presenter- If the concert is canceled by Local Presenter and not rescheduled for reasons other than union or labor difficulties, national calamity, natural disasters or other unavoidable Act of God circumstances, Local Presenter agrees to pay PASA full fee agreed upon within 30 days.

9. NOTICES. All notices to PASA hereunder shall be given in writing to Performing Arts Society of Acadiana, PO Box 52979, Lafayette, LA 70505.

10. AGREEMENT: This Agreement shall not be binding on Artist until executed on Artist's behalf by PASA. It is agreed that PASA is not obligated hereunder and shall not be responsible for any acts or defaults of Artist. Local Presenter acknowledges that he has not relied on any representation or warranty of Artist or PASA in entering into this Agreement. This Agreement constitutes the entire understanding of the parties, cannot be changed orally, and shall be construed, governed and interpreted pursuant to the laws of the State of Louisiana. This Agreement may not be assigned by Local Presenter but shall be binding on Local Presenter and Local Presenter's personal representatives and successors.

11. NON-DISCRIMINATION: Local Presenter also agrees that admission to, and seating in, the Hall will be without regard to race, color, religion or national origin.

12. CORRECT INFORMATION: Unless the local information required on he AGREEMENT BETWEEN LOCAL PRESENTER AND PERFORMING ARTS SOCIETY OF ACADIANA (PASA) is completely filled in-or corrected as necessary-by Local Presenter, the non-arrival of Artist caused by resulting lack of correct information will not relieve Local Presenter from full responsibility hereunder.
